MEMORANDUM.

The State Government has Introduced the implementation of recommendation made by the Pay & Pension Revision Committee for the employees & pensioners of the State Government employees and worker of the State Government establishments, PSUs and other organization w.e.f. 01-04-2017 and the form of "Pay Matrix" with 21 level at Annexure-I. Uniform fitment factor @ 2.25 has been approved for all categories of employees under Government of Tripura. Salary of an employee under new system is to be calculated by multiplying the existing basic pay (without D.A.) with fitment factor of 2.25 minimum pay of the initial pay scale shall be Rs.14,040/- per month and that minimum of highest pay scale shall be Rs.1,17,000/- per month pay maximum of the highest pay scale is Rs.2,11,440/- per month.

Following the step of State Govt. of Tripura, the TTAADC authority has also been pleased to adopt the said Pay & Pension Revision, 2017 for the all categories of employees under District Council own and deputed employees including pension & family pensioners for the purpose of new system is to be calculated by multiplying the existing pay basic pay (without D.A.) with fitment factor of 2.25 minimum pay of the initial pay scale shall be Rs.14,040/- per month and that minimum of highest pay scale shall be Rs.1,17,000/- per month pay maximum of the highest pay scale is Rs.2,11,440/- per month of their pay similar to state Government employees providing financial benefits is payable w.e.f. 01-04-2017.
