The Term and condition:-

1. The Tender is to be submitted in a two bid system (one Technical and other financial) Technical bid will be evaluated first which will be followed by financial bid.
2. Qualified Bidder will be short-listed on the basis of rates quoted per unit of plant guard. Tax and other Govt. dues. As applicable is to be mentioned separately. The bidder who has quote lowest will be declared "Successful".
3. Supplier will deposit their price offers along with a demand draft/D-call for an amount Rs.10,000/- (Rupees ten thousand) only in favour of Divisional Forest Officer, 82-Mile Forest Division, TTAADC in a sealed envelope superscripted "Tender for supply of hard drawn plant guard (hard drawn) with planting materials (Seedlings) for planting season during 2018-19 either in person or by post/courier so as to reach this office from 11.00AM to not later than 3.30 PM on 17<sup>th</sup> July'18 at the address given above. Any bid received before & after stipulated time will summarily be rejected. The sealed Tender box will be opened on 18<sup>th</sup> July'18 at 11.00AM.
4. Supplier should submit valid ITC/PTC, details of Bank account, Pan Card, Tan /GST along with the Tender. He should submit valid License for Tender.
5. The successful supplier will be register as vendor as per guidelines of MGNREGA.
6. The accepted rate shall remain valid for a period of 1(one) year from the acceptance of rates.
7. Total requirement of plant guards 500 and 1000 Nos. However, the quantity may increase or decrease and for which the successful bidder will be liable to supply required quantity of plant guard (hard drawn) & others with the same rate and same term and condition.
8. Tentative place of supply of the plant guards/hard drawn are Raishyabari Range/Block office.
9. Security Deposit: on acceptance of the Tender, the contractor shall deposit as security money, a sum calculated at the rate 10% of the tendered amount of the 1<sup>st</sup> Rs.2.00 (Rupees two lakh), 7.5% on the next Rs.3.00 (Rupees three lakhs) and 5% on the balance amount subject to a maximum of Rs.1.00 (Rupees one lakh) only as security deposit. The security money has to be deposit within 7(seven) days on receipt of acceptance order by the successful bidder by way of "Demand draft/D-call" pledged in favour of the Divisional Forest Officer, 82-Mile Forest Division, TTAADC.
10. The earnest money shall remain liable to be forfeited if the successful bidder fail to furnish the security money and execute the agreement bond with in stipulated time and the Tender so submitted will be treated as cancelled without further reference.
11. The Successful contractor shall have to enter into an agreement with the TTAADC, Tripura and cost to be incurred for the purpose shall be borne the contractor.
12. The rate should be quoted both in figures and words against each item clearly and without overwriting.
13. The copy of the agreement bond may be seen in the office of the undersigned during office hours on the any working day.
14. The security money may be forfeited to the TTAADC, if the successful bidder fails to supply the required quantity plant guard (hard drawn) and others within the time so specified.
15. The supply order may be placed in phase manner and accordingly hard drawn and others has to be supplied and fitting fixing within 15 (fifteen) days on the date of receipt of supply order from this end.
16. In case the suppliers fails to supply the required quantity in time, the offer will be automatically stand cancelled from the date of the default, and next higher bidder will be declared as "successful bidder without further correspondence.
17. Payment will be made against bill produce on completion of supply of the whole materials and fitting fixing completed by generating FTOs.
18. The successful bidder in case of failure on the part of the supplier to continue business, the EMD shall be forfeited. EMD on unsuccessful bidder will be returned/released within 45days of the closure of the tender.
19. Tax return of last 2(two) years must annexed with the technical bid and bid will be included SL No.15 of Terms and condition.
20. 14.5% VAT, 2% income Tax and 12% surcharge on income Tax to be deducted at source.
21. All the listed documents are to be submitted in the technical bid except rate.



22. The undersigned reserves the right to accept or reject any offer either partially or fully including that of the lowest bidder without assigning any reason. 4. Each tender should accompany a "D-call" Rs.5,000/- only against each item drawn in favour of the undersigned on any National Bank being earnest money without which no tender shall be treated valid for acceptance. There will be financial bid in the Range.
5. The earnest money of the unsuccessful bidder will be released immedietly against prayer from the concerned bidder, while earnest money of the successful bidder shall remain deposited as security money till the supply is completed.
