

**General Instructions:-**

**Scheme of the Examination:-** The Examination will comprise of two successive stages viz (i) Witten Examination ( Multiple Choice Type Test) (ii) Viva voce details as mentioned below:

1. **Witten Examination ( Multiple Choice Type Test) 100 marks:-** The Witten Examination will consist of one paper containing Multiple Choice Type Test Questions on General Ability Test with two hour duration. The Witten Examination will be screening Test for selection of candidates for admission to the Viva voce. The marks obtained by the candidates in the Witten Examination will not be taken into account for the purpose of determining the final merits list.
2. Viva-Voce (100 marks).
3. The selection of candidates shall be made by adding marks obtained in the viva voce and the Witten Examination. The position of the candidate in merit list will depend on the aggregate of both.

**(B) Interview, Viva- Voce :- 100 Marks.**

1. A candidate must secure minimum 30% marks in the viva voce to be eligible for being recommended for appointment to the Service.
2. The marks obtained in the viva voce will be added to the marks obtained in the written examination and the position of the candidate in the merit list will depend on the aggregate of both.
3. Applicant must be in possession of the prescribed minimum qualification(s) for the post on the closing date for submission of application as mentioned in the advertisement.
4. Date, time and venue of Witten Examination & Viva- Voce will be notified in due course.
