CORRIGENDUM

As a result of discussion in the pre- bid meeting held at 11.00 am on 21.12.2022, following changes of terms & conditions of DNIT No. 01/PO(ICAT)/ADC/2022-23 dated 14.12.2022 for leasing out the **'Operation and Maintenance of 10 nos. of Log huts along with other assets like 2(two) nos. 2BHK Log Hut for reception & staff accommodation etc at Khumulwng Eco Park Premises under TTAADC Head quarter Complex, Khumulwng, West District of Tripura during 2022-23'** are incorporated.

1	Process of Running Resorts	The tender has been called for running & maintenance of 10 +2 unit of Cottages with a restaurant to run the Resort at Khumulwng park with Reserve Value of Rs. 18, 60,240/- per annum basis.	Tender conditions are to be extended such a manner that any interested Bidder can run the Resort with Revenue Sharing basis and any infrastructure development required beyond our existing Cottages shall be done by the Bidder on Trunkey basis for which required land will be provided by the TTAADC.
2.	Further infrastructure development	There is no provision of extension of infrastructure with the funding of TTAADC however any developmental activities within Rs. 3.00Lakh can be allowed with the approval of TTAADC. Lease Value will not be changed.	Any infrastructural development can be taken up by the agencies on Trunkey basis for which only land will be provided to them only for lease period and infrastructure so created by the agency will have to leave with TTAADC only. Prior permission is to be taken from TTAADC before taking any activities regarding infrastructural development. Proportionate Revenue is to be shared to TTAADC which should not be less than 40 (forty) % of total revenue collection.
3	Process of submission of Alternative proposal of Tender.	<ul style="list-style-type: none"> Any tenderer can either offer their rate on Reserve value basis or on Trunkey basis with revenue sharing basis. Tender with alternative Proposal could be submitted after maintaining all terms & conditions of DNIT in/c submission of tender with duly signed tender documents along with Tender Fees of Rs. 4000.00 (Non Refundable) & EMD for Rs. 37,205.00 in the shape of DD / D-Call format drawn in favour of P.O(ICAT), TTAADC, Khumulwng. The Alternative proposal of tender should content with details of concept papers, land required, infrastructure to be created, fund involvement, projected revenue collection planning, market survey report of demand of resort etc.
