

Detailed terms & conditions:-

1. Tenderers shall have to submit their tenders in prescribed format which may be obtained from the development section, office of the Principal officer Fisheries, TTAADC Khumulwng on or before 20.01.2018 on payment of Rs. 1000/- (one thousand) only in cash or can be downloaded from the **website ttaadc.gov.in** and in that case the cost of tender documents should be deposited separately in the form of DD drawn in favour of the Principal officer Fisheries TTAADC from any TGB branch payable at Tripura Gramin Bank, Khumulwng Branch, Tripura.
2. Tender rates may be quoted item wise. Tenderer need to be submitted tender in sealed cover duly super scribed with **"Tender for Supply and installation of Ice Plant Machineries in TTAADC Area** under the Principal officer Fisheries, TTAADC on or before **24.01.2018** up to **3:00 PM** only and will be opened on **25.01.2018** at **3.30 PM** if possible in the office of the undersigned in presence of participated tenderer/their representative.
3. Tenderers should inform about their detailed address along with pin code, Phone no. and Fax no. if any for easier communication. The interested bidders shall submit their bid(s) along with all related papers as required & deposit Earnest money (as per terms & condition of NIT) etc. in sealed cover.
4. Tenderer should submit their previous experience certificate of Supply and installation of Ice Plant Machineries.
5. The Supplier should submit the document proof having facilities to train at least 1-2 persons from selected SHG for operation of Ice Plant, production of Ice Block and Ice Cream.
6. If the tender is found informal as per NIT the financial bid of the tender will not be considered to effect supply. Appropriate bidder shall be selected on the basis of lowest rate and other valid considerable condition as mentioned in NIT.
7. Procurement preference will be given to local eligible manufacturing enterprise as per clause 8. (excluding condition of sub clause 8.4) of Tripura Industrial Investment promotion incentives scheme 2007, except that registration with industry department will not be a precondition.
8. The rate should be offered with F.O.R up to destination to the Ice plant site in TTAADC area. The rate quoted in the tender shall be inclusive of all Taxes, freight and duties applicable. No agency charge / commission shall be entertained. **Tenderer should quote their rate item wise in figure and the total should quote in both figure & words in the prescribe format per unit Ice plant basis.** Any over writing in any figure/name in the tender form should be initialled duly. Any enhancement of rate within the validity period of contract will not be considered.

9. The tenderer should be accompanied with a earnest money deposit @ 3% of the quoted total price in the form of D-call in favour Principal officer Fisheries, TTAADC, Khumulwng, West Tripura payable on any scheduled nationalized Bank/Gramin Bank/Tripura State Co-operative Bank Ltd. (Cheques are no acceptable).
10. The local eligible manufacturing enterprise will have 75% exemption from payment of earnest money in terms of notification no. F. DI / TIS /SUB /4-2 (21)/ 2006 /P-III/ 10599-618 dated 21/07/2011 of Department of Industries & Commerce. Eligibility certificate for the same should be submitted along with the tender/bids documents.
11. As per finance department memo.No.10(19)-FIN(G)/69(P-1), dated 25/09/1998 all central and state public sector undertaking including those of other states will be exempted from deposit of earnest money and security deposit while bidding in the tenders. Valid documents shall require to be submitted with tenders.
12. Tender without EMD as mentioned above will summarily be rejected. The EMD will be released after validity period of contract in case of successful tenderer and in case of unsuccessful tenderer it will be released after finalization of the tender process.
13. **The earnest money of the successful tenderer shall be converted as security money.** And it will be released only after successful supply and installation.
14. Payment to successful tenderer shall be made on bill basis after completion of supply and installation of Ice Plant Machineries also successful demonstration in production of Ice Block and Ice cream for which it ordered for. No advance payment shall be made under any circumstances.
15. Income Tax / GST and other Taxes shall be deducted from the bill @ rate notified by the Govt. from time to time, if applicable.
16. The following certificates have to be submitted along with the tender form.
 - a. Copy of Permanent Account Number (PAN) Card issued by the income tax dept. GOI
 - b. Copy of Registration certificate/ Licence of the manufacture.
 - c. Copy of the Trade Licence /Authorized dealership certificate of the dealer.
 - d. Copy of GST Registration certificate
 - e. Copy of Income Tax clearance certificate.
 - f. Copy of Professional Tax Clearance Certificate.
 - g. The Experience of last performance.
17. The tendering authority reserves the right to negotiate the rate etc.
18. The penalty clause will be as follows :-
 - i. If tender surrendered before opening of the tender, there will be no penalty.
 - ii. If surrendered after opening but before negotiation, **25% EMD will be forfeited.**
 - iii. If surrendered after opening but before finalization, **50% EMD will be forfeited.**
 - iv. If surrendered after finalization but before signing of agreement, **75% EMD will be forfeited.**
 - v. If surrendered after signing of agreement, 100% EMD will be forfeited.
 - vi. If fails to supply within stipulated period security money to the full extent will be forfeited and firm may be black listed for a specified period as decided by tendering authority.
19. Any clause not mentioned above but mutually accepted will also be part and parcel of agreement. Issued supply order will also be a part and parcel of agreement.
20. Any suppression of facts in the tender from bidder's end will entail rejection of tender and other punitive action as per rule.
21. The Number of Ice Plant may increase with in the financial year.
22. Tendering authority reserves the right to accept/reject any tender including lowest one without assigning any reason.
