

Terms & conditions

- Quotation is to be reached on sealed cover envelope to the undersigned either by registered post / speed post / with A/D so as to reach this office within **1600 Hrs. on 10.01.2019.** There after no quotation will be accepted.
- Quotation shall be submitted along with photo copy of his / her trade license PTCC, Pan Card, GSTN, registration etc. with current validity duly attested on both pages by Gr- A Gazetted Officer. Attestation should not be more than one month old signature.
- The Quotationer should be submitted manufacturer license / Distribution license.
- The Bidder should have local presence/ establishment/ representative in Tripura.
- The Tendered should signed and duly stamped in every page of bid document.
- Materials should be delivered at Khumulwng.
- Quotationer should quote the rate for each item separately inclusive all taxes in/c loading and unloading charges.
- The successful quotationer shall have to supply the materials in full within 2(two) months after issue of supply order failing which earnest money will be forfeited without any notice.
