

Total admissible amount of D.A. shall be ignored while fraction of 50(fifty) paise shall be rounded off to the next higher rupee.


The expenditure on payment of Dearness Relief on pensioners/Family pensioners is debitable under the Major Head 2071-Pension and other Retirement benefit.
