

SCHEME FOR FINANCIAL ASSISTANCE TO ST YOUTH FOR PURSUING OF D.El.Ed./ B.ED.

A Good number of Qualified and Meritorious Scheduled Tribe (ST) Educated unemployed youth are unable to appear the Teacher Eligibility Test (TET) (Competitive Examination for recruitment in the posts of Government Teachers) for the job of Teacher of the Elementary Education Dept. in the state Govt. as well as the Central Govt. and TTAADC run schools due to lack of D.El.Ed./ B.Ed. (Bachelor of Education).

2. A good numbers of qualified & meritorious S.T youth are living within ADC areas and throughout the state of Tripura for which a onetime financial assistance @ 1.00 lakh only will be awarded for pursuing of two years D.El.Ed./ B.Ed. course. The eligible Educated Tribal youth are facing paucity of required fund for obtaining the D.El.Ed./ B.Ed. could be assisted offering a onetime financial assistances to enable them for applying the post of Teachers.

3. The Tripura Tribal Areas Autonomous District Council will encourage by sanctioning one time financial assistance to the eligible ST meritorious youths in addition to the normal scholarships of Tribal Welfare Department, Government of Tripura for pursuing of two years D.El.Ed./ B.Ed. course to the colleges/Institutions approved by National Council for Teacher Education (NCTE) and affiliated University/State University/recognized Board located in the state and outside of the Tripura.

4. The youths will be selected by the Principal Officer, Education, TTAADC on the basis of merit and annual family income upto @ Rs.2,50,000/- (Two Lakhs & fifty thousand) only per annum.

5. The required fund for the above scheme will be arranged from the budgetary provision of TTAADC.

6. The TTAADC authority will have no any liability for providing Job after completion of the courses.

7. **The eligibility criteria of the candidates:-**

- i. The candidates/applicants should be inhabitant of TTAADC area and throughout the state of Tripura who passed the H.S(+2 stage) Examination or equivalent examination securing at least 45% marks and above in H.S(+2 stage) Examination at any discipline in regular schooling for submission of application in connection with D.El.Ed./ B.Ed. course or as per criteria approved by the (NCTE) and affiliated University/State University/recognized Board located within Tripura and outside of Tripura. The candidates will be selected 50% candidates who passed from the TBSE and 50% candidates from CBSE, ISC board.
- ii. Selection of candidates will be made on Merit basis.
- iii. The intending candidates should be belonging to the BPL/AAY, APL family Ration card holders not exceeds annual family income of Rs. 2.50 lakhs.
- iv. Family income of the eligible Candidates must not exceed Rs.2.50 lakhs per annum. He or she should submit family income certificate from the Revenue authority i. e. SDM / D.C/DCM.
- v. The age of intending candidate upto 37 years age as on when the notice is issued or fixed date.

8. **Selection procedure of the eligible candidates:**

- i. The application would be received by the Principal Officer, Education, TTAADC, Khumulwng through open advertisement in daily local news paper within the stipulated date. No application will be entertained after the stipulated date & time and selection be made accordingly.
- ii. The applicants who are fulfilled the above criteria as stated above may apply for the scope.


- iii. Incomplete application is automatically liable to be treated as cancelled.
- iv. The number of seats for extending financial assistance to the eligible ST meritorious youths for pursuing of two years D.El.Ed./ B.Ed. course will be fixed by the appropriate authority.
- v. Maximum 200 (Two hundred) candidates will be provided one time financial assistance per academic year. The number of seats may increase or decrease as per decision of the authority.
- vi. On receiving the application from the eligible candidates, a list of selected candidates along with wait list be prepared and be displayed in the website of TTAADC as well as in the notice board of the office with the required approval of the authority. The candidates who are in wait list may get the chance if any candidates not taken the chance or refuse to take the scope successively.
- vii. The decision of the authority of the TTAADC shall be final in all respect on the matter.

9. Selection of eligible college and admission procedure .

- i. The selected candidates who will eligible as per approved criteria should select the college / institute at his own from the empanelled Colleges/ Institutes of the Department of State Government. Institute having the approval of NCTE and affiliated by any Central University / State University / Recognized Board at his own.
- ii. The candidate must declare that the institution, he/ she got admitted is having the approval of NCTE and affiliated by any Central University / State University / Recognized Board.
- iii. The selected candidates should take admission to the college/ institute at her / his own initiative and then he or she may apply for financial assistance.

10. Payment procedure .

- i. Financial assistance will be provided only on production of admission related papers to the Principal Officer of Education, TTAADC.
- ii. The amount as fixed by the authority will be deposited to the Bank account of the concerned college with a copy to the candidate. In no case payment will be made to the candidates.
- iii. The sanctioned amount will be released to the concerned colleges/institutions in 3 (three) phases viz. first installment (50%) on receiving the proper documents of admission of candidate, 2nd installment (25%) on receiving the pass certificate of successful completion of 1st year course and 3rd installment (25%) on receiving after the successful completion of the course or the Department will consider the norms of the college/ institute / university regarding the payment of fees if required.
- iv. An MoU (Memorandum of Understanding) is to be prepared by the Principal Officer of Education, TTAADC should be signed by the appropriate authority of the selected college and Principal Officer of Education, TTAADC regarding payment of fees and the authenticity of the college etc.
- vi. Selected candidate has to bear to and fro journey cost.
- vii. The selected candidate will have to be completed the course within stipulated time of the college/institution, if any selected candidate failed or unsuccessful to complete the courses in time, the last portion of approved amount will not be released. The said balance amount of fund is to be borne by the concerned candidate by herself/himself.
- viii. The candidate will submit a bond to the authority in prescribed form in semi papers regarding fulfillment of the courses as per criteria prescribed by the selected colleges/ Institutions and Principal Officer, Education, TTAADC.
