Tender documents consisting of qualification information and eligibility criterion of bidders, plans, specifications drawings, the schedule of quantities of the various classes of work to be done and the set of terms and conditions of the contract to be compiled with by the bidder can be seen in the office of the Executive Engineer, South Division, TTAADC, B.C Manu between hours of 11.00 am and 4.00 pm on any working days between 02/07/2021 to 14/07/2021, Tender documents will be issued from this office during the hour specified above, on payment of Rs.1000/- (Rupees one Thousand ) only, in cash/Demand Draft(Non Refundable) on any working days as specified above on production of documentary proof of registration of the firm along with on application.

3. Receipt of applications and issue of tender forms will be stopped by 16.00Hrs. on 14/07/2021. Tender documents consisting of plans, specification the schedule of quantities of the various classes of work to be done and the set of terms and conditions of contracts to be compiled with by the contractor whose tenders may be accepted and other necessary documents can be seen in the office of the Executive Engineer, South Division, Office of the South District Sub-Division, Garjee. & Office of the Assistant Engineer, Jatanbari Sub-Division, Jatanbari and Rupaichari Sub-Division TTAADC, on any working day during office hours(except on Sunday and Public holiday).

4. Tenders submitted/Posted in sealed envelope only through post office/speed Post /Courier Services with the name of work and DNIT & PNIT No. written on the envelope will be received by the Executive Engineer South Division, TTAADC, B.C. Manu up to 15.00Hrs on 19/07/2021.

5. Sealed tender shall be opened by the Executive Engineer, South Division, TTAADC, B.C. Manu, in presence of intending tenderers and other contractors who may likely to be present at 15:30 Hrs. on 19-07-2021 if possible.

6.a) Tender documents must be delivered to office of the Executive Engineer, South Division, TTAADC, B.C Manu on or before 15.00 hours on 19/07/2021 if the office happens to be closed on the date of receipt of the bids as specified, the bids will be received on the next working day at the same time and venue.

- b) Tenders will be opened at 15.30 hours on 19/07/2021 (if Possible) in the office of the Executive Engineer, South Division, TTAADC, B.C Manu. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. Tenders must be accompanied by the Earnest Money of the amount specified for the work in the Table. The earnest money will have to be in any one of the forms as specified in the bidding document.
8. The tender must be submitted his/her tender along with photo copy of his/her ITCC, PTCC Registration of enlistment, Labour license, Pan card GST etc. of current validity duly attested on both page by Gazeted Officers of the state/central Govt. Attestation should not be more than one month old. Attestation of signature of tenderer and photo copy to be mentioned while attesting ITCC.
9. If a tenderer is enlisted in the PWD as well as in MES, P&T, Railways or State PWDs he shall be eligible to tender for works up to the amount permitted by virtue of his enlistment in the PWD even if he may be authorized to tender for bigger works in the CPWD/MES/P&T and/or Railway
10. Tendering documents will not be sold to intending tenderer who are near relatives of Divisional Accountant or Superintending Engineer or Executive Engineer or Assistant Engineer or Junior Engineer of the circle in which the work is to be executed.
11. No Engineer or Gazatted rank or other office employed in the Engineering or administrative duties in On Engineering Department of the state government is allowed to work as a bidder for a period of two years after his retirement from Government service without Government permission. This contract is liable to be cancelled if either the bidder or any of his employees is found any time to be such a person who has not obtain the permission of the Government as aforesaid before submission of the tender or engagement in the bidders service.
12. All contractors who required more than 180 days time extension for the works executed/executing under NITI AAYUG fund and other central funded works will be treated as defaulter contractor and not be allowed to participate in tender for the forth coming tenders for the period of 2(two) years from the date of completion of work.
13. If the percentage quoted by a bidder is found to be either abnormally high or due to unethical practices adopted at the time of tendering process, such tenders shall be rejected.
14. The accepting authority reserves the right to accept tender other than lowest one / rejects any or all tenders without assigning any reason.
