The concerned Implementing Officers shall implement the scheme as per guide line of the department during the year 2015-16 observing all codal formalities before incurring the expenditure.


The expenditure involved shall be debitible to the head of account-2405-00-101-99-77-47 under State Transfer Fund during the year 2015-16.

The Utilization certificate should be submitted by the implementing Officer after successful Implementation of the Scheme along with physical and financial report.


