

The expenditure shall be debitabale from the fund received by the PO (ARDD), TTAADC for this purpose against Memo No. No.F. 57(8)/ADC/ARDD/T.Fund/2014 (Vol-II)/2,464-76 dt. 07-02-2015 under the Head of Account, 2403 AH, 102-Cattle Dev., (a) Payment of incentives to the Cattle owners & AI Technicians during the year 2015-16.

The Utilisation Certificate shall have to be submitted to the Principal Officer (ARDD), TTAADC with a copy to the E.O(Fin), TTAADC after completion of implementation of the project.


